Children become eligible for adoption through Child and Family Services either because birth parents have consented or because the Court has determined that the parents are unable to care for the child. Where possible, social workers with Child and Family Services involve birth parents in planning for their child. There is particular recognition given to preserving the unique heritage and cultural ties of aboriginal children. Family service and adoption workers with Child and Family Services agencies get to know the children who come into their care. Where children will not be able to return to their families, it will be determined whether adoption or long-term care is in the children's best interest. If the child is old enough, he or she helps to make this choice.

Following adoption placement of a permanent ward, financial assistance is available for families who adopt a child with special needs that require special services or for families who are adopting more than one child from the same family.

MCB is a provincial income supplement program providing monthly benefits to lower-income Manitoba families needing assistance with the cost of raising children.

Under the program rules, you cannot receive MCB benefits if you receive

income assistance. If you receive only the health care benefits portion of provincial Employment and Income Assistance, you can apply for MCB benefits. Wards of the Province and children in temporary placement under The Child and Family Services Act are NOT eligible for MCB.
